# Cream City Roses Final Report

The 2021 ARS National Convention and Rose Show, Cream City Roses, is now wrapping up all the last details and responsibilities. The process of planning and holding the event during a time of COVID was a challenge that was not anticipated. The multiple waves of the virus affected all aspects of the convention, especially limiting our registration numbers and subsequently our income. With nimble planning and alternative means of presentation via the web, the events affected were still successful, allowing presenters and participants the chance to "attend" the Convention.

We offer the following information as a final documentation for the event.

Income for the convention came from a variety of sources other than general registration.

Diane Sommers was instrumental in procuring funds from a variety of sponsors that helped to defray the cost of the events to the registrants. Our income broke down as follows:

Sponsorships	\$ 32,600.00
Silent Auction	\$ 2,969.00
Raffle	\$ 1,625.00
Donations	\$ 10,999.96
Registrations	\$ 55,460.00
Webinar Registration	\$ 1,979.39
Miscellaneous	\$ 2,992.00
Total:	\$108,443.35

Our total expenses for the entire event were \$100,393.78. Additionally, we made refunds to twenty-eight individuals in the amount of \$2,294.60.

We were very fortunate to have enlisted the services of Sherry Hoskins, Global Account Executive with Conference Direct, who negotiated our contract with the Pfister Hotel. The contract agreement limited our liability in several areas. Additionally, Sherry was able to reduce our room-night minimums as COVID persisted and we were receiving cancellations. In the end, we were still short of our contracted room-night obligation. With Sherry's further negotiation, the Pfister reduced our liability by 50% (\$7,500.00), allowing the Convention financials to end in the black.

With all expenses for the Convention paid, a profit of \$5,754.97 was realized. That amount was distributed per contracts and agreements as follows:

ARS:	40%	\$2,301.99
Host Districts:	60%	\$3,452.98
NCD:		\$1,208.54
IL-IN:		\$1,208.54
CD:		\$1,035.89

The seed money deposited with the Convention was also returned to the three hosting Districts. We appreciate the participation of the Districts in this manner.

Another impressive area for donations was for the convention swag bags. With the leadership of Joe & Carrie Bergs, thousands of dollars of in-kind donations were received and distributed to our registrants.
